Library extends, reschedules art exhibits

The world's art museums and galleries have been hard-hit during the coronavirus pandemic. Art openings have been canceled, specialized services that crate and move art from museum to museum or artist to collector have stopped operating, and even though some galleries and museums have reopened, many members of the public are staying home rather than going out to view exhibits or purchase art.

The Georgetown Public Library holds art exhibits year-round, but when we closed to the public in mid March our exhibit calendar was affected, too. The very popular annual Texas Society of Sculptors show has been canceled for this year, and scheduled exhibits by City of Georgetown staff members and Mark Stalaker will be rescheduled, as will shows by Lucas Adams and the Sun City Creative Clay and China Club. Each one of these postpone-

ments represents a terrible loss for the artists and the public, but we look forward to getting them rescheduled during better times.

Now that the library has reopened to the public with limited services, it is possible again to make a visit to the library and view art. The two exhibits that had just been installed when the library closed have remained up and have been extended. Now is your chance to stop by to see *Infrastructure* by Linda Murray in the second floor Bridge and Hall galleries. It will remain in place through June 13. "Colors" by Wladimir Barantschikov is in the first floor Café Gallery. It will remain in place through July 18.

And on June 17, a new exhibit will open — *Art in the Family* by artist, teacher and consultant Sonia

Colonna Mathis. Sonia has a BFA in studio art from the University of Texas at Austin.

The library is open from 9 a.m. to 6 p.m. Monday through Friday and from 9 a.m. to 5 p.m. Saturday. We encourage visitors to wear a mask and to spend 30 minutes or less in the building, but please do visit our exhibits while you are here — and please look for ways to support our local artists, including purchasing art from open venues or online.

One final note about art in the library: Exhibit proposals will be accepted until midnight Friday from artists who would like to be considered for an exhibit in the library in 2021.
