Library installs 2 new exhibits, adjusts hours

The summer heat has set in, and indoors (with masks, of course) will be the preferred location for many for the next couple of months. But the Georgetown Public Library's air conditioning is on, new reading materials are available for check-out, and today exhibits by two new-to-us artists open on the first and second floors.

In the second floor Bridge and Hall galleries, library visitors will find painter Rachel Hurst's exhibit *The Color of Animals*. Hurst is the daughter of famed western artist Oleg Stavrowsky, so growing up she was surrounded by world-class art. For a time as an adult, she made her living painting enormous ceiling and wall murals in the Italian fresco style. She now produces fine art incorporating two

of her favorite things — animals and patterns. She uses color and pattern to frame the animals in the way they make her feel when she looks at them. And she donates 10% of her art sale profits to Safe In Austin, a Leander nonprofit organization that rescues animals from severe abuse or neglect.

Hurst has a range of other interests in addition to art. She spent her childhood devoted to competitive figure skating, she holds a national 8-ball title and she won a tournament qualifying her to play in the World Series of Poker. She formerly competed on the Women's Professional Billiard Association Tour. She is an

avid cruciverbalist (a person skillful in creating or solving crossword puzzles). She lives with her husband and three cats in Austin.

Jennifer Gillen's exhibit *Petal & Ink* is in the first floor Café Gallery. Gillen is a Georgetown-based artist who works in ink, oil paint and watercolor. Her work focuses on botanical portraits that allow intimate views of flowers. She works to convey beautiful contrast and visual movement in her ink drawings.

She is a member of the Botanical Art Collective of North Central Texas, the American Society of Botanical Artists and the Society of Botanical Artists Southwest. Her work has most recently been featured in gallery shows at the Botanical

Research Institute of Texas in Fort Worth.

Gillen's exhibit *Petal and Ink* is the culmination of a year's work in pen and ink using a variety of techniques including stippling, etching, and ink wash to create a collection of ink drawings that highlight popular garden flowers. The flowers featured in her exhibit in the library were found in botanical gardens throughout the United States, as well as residential gardens in Georgetown.

A few things that for now visitors cannot do in the library — We are not accepting donations of books or other materials (though we can always use donated funds!). We do not have any public computers available nor any meeting or study spaces.

One last note: We have slightly reduced our open hours beginning today — we're now closed on Wednesday mornings so our staff can all pitch in and shelve returned materials. We know that library materials are crucial to the well-being of many in Georgetown, and we appreciate all the support we're getting from the community during this time. See you in the library!
