Texas Society of Sculptors awards announced at library

s visitors to the Georgetown Public Library will have noticed, the library dedicates a great deal of staff time and building space to art. Here is a bit of art-related news, including

awards in the Texas Society of Sculptors 13th Annual Summer Show exhibit, a special display by fiber artist and psychotherapist Susan Hoppenworth in commemoration of the twentieth anniversary of the 9/11 attacks, and a pastel exhibit by members of the Central Texas Pastel Society.

Awards were announced August 15 in the Texas Society of Sculptors exhibit. Awards are funded by the City of Georgetown's Arts and Culture Board, and they are determined by the public (People's Choice Award), the library staff (Librarians' Choice Award) or a juror (first, second, and third prizes as well as three honorable mentions). This year's awards juror is Graeme Durant, assistant curator at the Umlauf Sculpture Garden and Museum. Here are the award-winners:

- People's Choice "And He Did Ride" by Ronnie Wells
- Librarians' Choice "Carol's Bouquet" by Ken Law
- First Prize "Rapunzel's Tower Under the Full Moon" by Valerie Chaussonnet
- Second Prize "1.618" by Evan Horn
- Third Prize "Pirate's Woman" by James R. Woodruff
- Honorable Mention "Ready for Takeoff" by Dar Richardson
 - Honorable Mention "Jave" by Ken Law
- Honorable Mention "Laugh, You Jester. You Are Not Allowed to Cry." by Czes Sornat

The show lasts through September 17 and features 78 works of sculpture by 40 artists.

Another exhibit, Susan Hoppenworth's "Works and Words from a 9/11 First Responder," is coming up in the next few weeks, corresponding with the twentieth anniversary of the September 11 attacks.

Ms. Hoppenworth is a fiber artist and licensed psychotherapist. In the aftermath of the 2001 attacks, she traveled to New York City and served as a first responder, counseling victims as well as other first responders. Since that time, she has created multiple art quilts focused on her experience and perceptions, and those quilts, as well as journals and other mementos from her time in New York, will be on display in the library.

On September 10, Susan's many 9/11 commemorative quilts will be on display from 9 a.m.-6 p.m. in the second floor Hewlett Room, and at 4 p.m. that day she will give an artist talk about her experience and the ways she has used quilting and writing in

the aftermath of that trauma. The 4 p.m. talk will be followed by a reception, also in the second floor Hewlett Room.

A selection of Susan's work, journals and mementos will be on display September 2-23 on the library's second

floor bridge, but the only opportunity to see all of the collection will be September 10 from 9 a.m. until the end of the reception at 6 p.m.

Finally, "Symphony of Images," a new exhibit by members of the Central Texas Pastel Society, opens in the library on August 25 in the second floor Bridge and Hall galleries. "Symphony of Images" extends through September 26 and features a collection of pieces that were done to meet the group's monthly challenge themes over the past year, during which they met via Zoom rather than in person. The themes ranged from seasons of the year to "Paint like your Favorite Artist." Their shared art was sharing life in a difficult time.

The Central Texas Pastel Society exists to promote the medium of pastel. They meet monthly September through May with workshops, demonstrations and exhibiting opportunities. They welcome artists at all levels of their artistic journey.

Finally, an update on library hours. Our hours now are Monday-Thursday 9 a.m.-8 p.m., Friday from 9 a.m.-6 p.m., Saturday from 9 a.m.-5 p.m., and Sunday from noon-5 p.m. Please note that the library (and all art exhibits) will be closed Monday, September 6, for Labor Day.
